# Rules, Regulations, and Laws for International Animal Rights

These laws apply to all operations of International Animal Rights (IAR), from now until the end of time.

- 1. IAR is an animal sanctuary.
- 2. IAR is not a religion.
- 3. IAR is not a political organization.

#### 4. IAR Goal:

It exists for the benefit of its animals, not for the humans who work here as their caretakers.

No financial gain of any kind is allowed for humans at IAR. Those who work here earn money from outside sources and use it for the care of the animals. They are not permitted to gain financially from any affiliation with IAR. I hope this is clear for the future. Any internal processes created must align with this clause and every other clause in this document.

#### 5. IAR will never ask donations

This applies to its website, in person, and in any other form. The founder, moses, allocated \$400,000 to start IAR. In the future, members will work to generate income and use it for the animals. They will never ask for donations from the public.

#### 6. IAR is not a zoo

While IAR will have animals, and people may make appointments to bring their children to play with animals, IAR will never charge admission. No animals will be caged, and the sanctuary will remain free to the public. Visitors may bring carrots for the rabbits or apples for the cows, but IAR will never ask for donations or money.

#### 7. Treatment of animals

The animals at IAR are not pets, nor are they zoo animals. They are adopted children of the humans who work here. They are free to roam the farm, play daily, return to their rooms to sleep, and live as the children of the caretakers. The animals will never be forced to work. For example, cows will not be involved in farming production. The animals will live free of responsibility.

## 8. The responsibilities of people working at IAR

Those who work at IAR will have three key responsibilities:

(a) Engage in productive work in the human community to earn money. Workers voluntarily allocate any amount of their earnings to the care of the animals. There is no pressure or obligation

to contribute any specific amount. They will receive education in marketing and sales of vegan products and publications and will receive these products for free to sell online. Workers may use their earnings as they see fit, but everything is voluntary, and no donations will be solicited from the public.

- **(b)** Care for the animals by feeding them, cleaning their living areas, and taking them out to play. This is voluntary work, and people are here because they like animals and want to do it.
- (c) Promote the concept of animal rights globally through the internet. Workers will receive training in internet marketing and be provided with the necessary resources, such as a computer, internet connection, and web presence.

#### 9. IAR is not a cult

IAR is not a religion, nor is it a means for humans to make money. The humans who work at IAR will earn money for their children—the animals they care for. The animals are free to do what they wish, such as eat, play, and sleep. They will not be forced to work but may pose for photos for the website to help promote animal rights.

IAR is not a political party or movement. It is not affiliated with any religion, be it Judaism, Islam, Christianity, or otherwise. IAR does not preach any doctrine other than animal rights. We do not list what we are not; instead, we focus on what we are.

IAR is an animal sanctuary for free animals, supported by volunteers who work to benefit the animals and promote the concept of animal rights. IAR has no political agenda. We are solely concerned with the well-being of the animals here and promoting animal rights worldwide. We hope that, within the next thousand years, humanity will recognize the simple truth that animals deserve the same legal rights as humans.

The political or religious affiliations and views of those who work at IAR are irrelevant. They may be Jewish, Muslim, Christian, agnostic, or anything else. As long as they are here, their duty is to care for the animals. Outside of IAR, their beliefs are their own and unrelated to the sanctuary.

#### 10. Structure of IAR

IAR is a trust. moses, the founder, is the grantor, and IAR is the beneficiary. For now, the grantor serves as the general executor. As others join, the role of executor will be delegated. IAR is in the process of registering as a charity organization in New Zealand. Trust documents and other paperwork have been sent to the charity organization of New Zealand, and the process has begun.

# 11. Voting and decision-making process

Currently, there is only one member of IAR, moses. Land has been purchased, and a construction company is building the animals' living quarters. Once the construction is complete, we will begin advertising to attract animal rights enthusiasts from the Earth community. In the future, members will participate in decision-making about the activities and care of the animals. As all work here is voluntary, decisions will be made by consensus. If someone disagrees with a decision, they are free not to participate. Every member will have one vote, and decisions will be made by agreement. The principles of no donations, no financial gain for humans, no zoo-like conditions, and no political or religious affiliations are fundamental and will be accepted by all members.



## 13. IAR is for these people:



Humans have a tendency to cheat one another, and they also cheat themselves. To ensure that this never happens in IAR, I will repeat the Law again.

3300 years ago I said clearly: "You shall not kill innocents."

# 14. No cats, dogs, or other corpse-eating animals

We do not adopt cats and dogs. I have seen some intellectually challenged so-called "vegans" who keep cats and dogs. They go to the supermarket and buy food for them in metal cans, too ignorant to understand that the content of those cans is the corpse of murdered pigs, cows, chickens, sheep, and other animals.

If you want to adopt a cat or dog, **you must keep them vegan.** You are not allowed to kill other animals to feed your cat, dog, or any other naturally carnivorous animals. Cats and dogs are dumb; they are not responsible—you humans are responsible. If you want to keep cats or dogs, you must spend more time and money preparing vegan food for them so they do not become malnourished, and so you do not kill other animals.
